SAFEGUARDING & MANAGED MIGRATION UPDATE

JULY 2010.

CRB APPLICATIONS.

The new purple coloured forms must now be used. The old white coloured forms will no longer be accepted by TMG.

The new purple forms and application packs can now be obtained by contacting TMG - ecb@tmgcrb.co.uk or 0845 251 3000. Any queries relating to completing the new application forms should be directed to TMG and not the YCB.

Please read the new instructions carefully as changes have been made to the layout and the types of identification evidence which will be accepted.

VETTING AND BARRING SCHEME.

The registration phase of the new legislation was put on hold by the new government pending some 'Re-modelling'. Timescales are not yet known. Those matters which came into force on 12th October 2009 remain in force. These relate mainly to not using barred persons and the need to refer to the ISA details of people who have been removed from working with children / vulnerable adults.

The training of key personnel from all our affiliated clubs has therefore been put on hold pending the outcome of this 'Re-modelling'.

The need for certain people involved in cricket to have a current CRB clearance continues please refer to list in Safe Hands.

JUNIORS IN OPEN AGE CRICKET.

The ECB are in the process of reviewing their decision regarding minimum ages in senior cricket. Under 12's (Year 7) still cannot play in Open Age Competitive Cricket – Under 13's (Year 8) can play with appropriate consents in writing including a level 2 coach.

MANAGED MIGRATION.

The government have announced plans to tighten up the rules. It is not yet known how this will affect Tier 5 professionals or Non EU amateurs coming in to play cricket.

Holiday Visas and most Student Visas do NOT allow holders to coach or play as a professional.

PHOTOGRAPHY.

An updated policy was published a few months ago. Clubs are reminded to check with opposition sides before permitting photographs and video to be taken to ensure appropriate consents have been given. See the ECB website for the full details.

FAST BOWLING DIRECTIVES.

Slight changes were made over the winter allowing the younger bowlers to bowl more deliveries. A new guideline was introduced commonly referred to as 7-4-2 = in any 7 day period a bowler can bowl on no more than 4 occasions and on no more than 2 consecutive days.
